GENERAL CONDITIONS

- The Permittee shall file in the office of the Executive Director of the Washington County Sewer District I a notice of intention to commence work at least 48 hours in advance of the time of commencement and shall also notify him promptly upon completion of work.
- The permitted work shall be inspected by an authorized representative of the Sewer District who may order the work suspended if the public interest so requires. **NO WORK MAY BE BACKFILLED WITHOUT DISTRICT INSPECTION.**
- Inspections of completed work will be done between 8am & 3pm, Monday - Friday. Up to 24 hours notice may be required to schedule an inspection. Inspections scheduled or required outside of these times will require an additional \$75 surcharge.**
- The County of Washington, the Washington County Sewer Commission, or its agents shall in no case be liable for any damage or injury to the structure or work herein authorized which may be caused by or result from future operations undertaken by the Washington County Sewer District I and no claim or right to compensation shall accrue from any such damage.

5. The Permittee is responsible for obtaining any other permits, approvals, lands, easements, and right-of-way which may be required for this project.
6. The Permittee agrees that the Permit is contingent upon strict compliance with the Sewer Use Laws of Washington County. This Permit may be revoked if determined that the Sewer Use Laws of Washington County are violated. Sewer Lateral installation instruction summary available upon request.
7. Any existing septic tanks, cesspools, etc., shall be pumped out by an approved hauler. Any existing septic tanks, cesspools, etc., shall be crushed and/or filled with dirt, gravel, or sand. Pipe bedding and haunching materials shall be #1 or #2 stone.
8. All Permittees agree to pay a \$25.00 inspection fee per unit **PLUS District expenses if the District must excavate to a depth deeper than five (5) feet below grade***.
9. For new taps the permittee also agrees to pay:
 - () \$1,000 Single family dwelling in the District
 - () \$1,000 Two family dwelling in the District
 - () \$1,000 Per Unit PLUS all District Expenses for Commercial or Industrial Buildings in the District*
 - () \$2,500 per unit PLUS all District Expenses for all Out of District dwellings, or commercial, or industrial buildings*

10. The applicant shall supply any plans, specifications, or other information considered pertinent in the judgment of the District Director.
11. Permit to discharge will not become valid until the work is properly inspected.
