A Local Law Providing for the Maximum Exemption Allowable for the Alternative Veteran's Exemption from Real Property Taxation.
3. Local Law 3 of 2006  
**(Introductory Local Law "B" of 2006)**  
A local law superceding Local Law No. 1 of 2003 as Amended and Authorizing County Administration of the New York State Uniform Fire Prevention & Building Code.

A local law providing for powers of the budget officer to revise, alter, or change the requested allotments in the budget of the County of Washington pursuant to County Law Section 375

A local law superceding Local Law No. 3 of 1983 Providing for the duties and position of County Administrator for the County of Washington.
6. Local Law 6 of 2006  
**(Introductory Local Law "F" of 2006)**  
A local law superceding Local Law No. 2 of 1983 providing for the appointment and qualifications of the Pleasant Valley Administrator.
7. Local Law 7 of 2006

8. Local Law 8 of 2006
