

LOCAL LAWS 2007

1. Local Law 1 of 2007
(Introductory Local Law "H" of 2006)
A local law providing for salaries of Co. Adm., Co. Atty, DSS Com., PV Adm., Supt. DPW, Sheriff, Co. Clerk, Treas., RPTS Dir., Elec. Com., Coroners, Pers. Dir.
2. Local Law 2 of 2007
(Introductory Local Law "K" of 2006)
A Local Law Regulating Residency and Other Activities of Sex Offenders.
- Introductory Local Law "A" of 2007**
(This law was introduced at the April 20, 2007 meeting. Res. No. 112 to Set a Public Hearing was defeated and this law was referred back to Public Safety Committee.)
A Local Law Superseding Local Law No. 3 of 2006 as Amended and Authorizing County Administration and Enforcement of the New York State Uniform Fire Prevention and Building Code.
3. Local Law 3 of 2007
(Introductory Local Law "B" of 2007)
(A public hearing was held 6/15/07 but Res. No. 173 dated 6/15/07 to adopt this law was withdrawn. Res. No. 203 dated 7/20/07 adopted Local Law B of 2007.)
A Local Law Superseding Local Law No. 3 of 2006 as Amended and Authorizing County Administration and Enforcement of the New York State Uniform Fire Prevention and Building Code.
4. Introductory Local Law "C" of 2007
This Local Law is subject to permissive referendum. (Local Law No. 1 of 2008)
A local law providing for salaries of Co. Adm., Co. Atty, DSS Com., PV Adm., Supt. DPW, Sheriff, Co. Clerk, Treas., RPTS Dir., Elec. Com., Coroners, Pers. Dir.
5. Local Law 4 of 2007
(Introductory Local Law "D" of 2007)
A Local Law establishing a rate schedule of charges for the discharge of sewerage into the Wash. Co. Sewer District No. 1 sewerage system and all sewer tributary thereto for fiscal year 2008.
6. Local Law 5 of 2007
(Introductory Local Law "E" of 2007)
A Local Law establishing a rate schedule of charges for the discharge of sewage into the Wash. Co. Sewer District No. 2 sewerage system and all sewers tributary thereto for fiscal year 2008.
7. **Introductory Local Law "F" of 2007**
(A public hearing was held 12/21/07 but Res. No. 352 to adopt this local law was withdrawn and Res. No. 351 issuing a "Neg. Dec." in relation to LL F was tabled. Res. No. 86 to Adopt LL F was considered by the Board 2/15/08 and was tabled. Res. No. 85 issuing a "Neg. Dec." in relation to LL F was adopted 2/15/08.)
A Local Law to prohibit illicit discharges, activities and connections to the Wash. Co. Separate Storm Sewer System.

8. Local Law 6 of 2007
(Introductory Local Law "G" of 2007)

A Local Law providing for the Real Property Tax Exemption for Cold War Veterans Pursuant to Real property Tax Law §458-b.
