1. Local Law 1 of 2011  
**(Introductory Local Law “A” of 2011)** A local law Permitting Members of the Community Service Board and its Subcommittees to Serve for More Than Two Terms Consecutively.
2. Local Law 2 of 2011  
**(Introductory Local Law “B” of 2011)** A Law Against the Disruption of Funeral Related Events.
3. **Introductory Local Law “C” of 2011**  
(Resolution No. 146, to Adopt Local Law C was presented 6/17/11 and defeated by roll call vote.) A Local Law Requiring Certain Records to be Kept by Dealers in Secondhand Articles and Placing Certain Restrictions on the Purchase and Sale or Disposal of Said Secondhand Articles.
4. Local Law 3 of 2011  
**(Introductory Local Law “D” of 2011 Amended 05/31/11 at presentation.)** A Local Law amending Local Law No. 1 of 2008 Providing for the Establishment of a Schedule for the Salaries of the County Administrator, County Attorney, Commissioner of Social Services, PV Administrator, Superintendent of Public Works, Sheriff, County Clerk, County Treasurer, Real Property Tax Director, Coroners, Election Commissioners, Director of Personnel/Civil Service for the Year 2008.
